Disciplinary Action taken in July, August and September 2017.

One of the main functions of the Board of Valuers, Appraisers and Estate Agents Malaysia is to maintain the highest standard of the practice of Valuation and Estate Agency.

The latest disciplinary cases brought by the Board against estate agents for breaching the Valuers, Appraisers And Estate Agents Act 1981 or rules made thereunder including the Malaysian Estate Agency Standards and Malaysian Valuation Standards which aids the provisions of the said Act shows the Board's seriousness in upholding the integrity of the profession.

These cases illustrate the misconduct which had been committed and the charges which were brought as well as the penalties that were imposed by the Disciplinary Board upon the respective respondents. The cases are examples of breaches of the respective regulations and the penalties that are meted out for breaches depending upon the facts and circumstances of each case.
