Our renewal notifications dated 1 October 2020, 11 February, and 23 March 2021 refers.

EFFECTIVE 1 APRIL 2021, those who have not completed their renewal of their authority to practice for year 2021 (inclusive of those with status '**DRAFT**', '**REJECTED**' AND '**AWAITING PAYMENT**') will have their license **removed** from the Register or the Register of Probationers (whichever applicable) pursuant to Section 25(1)(d) of the Valuers, Appraisers, Estate Agents and Property Managers Act 1981 (Act 242) and Rules made thereunder.

Applications for reinstatement of authority to practice (for persons removed from the said Registers pursuant to Section 25(1)(d)) **may be** reinstated as soon as he/she has applied for reinstatement by submitting the following hardcopies of the documents (**provided your documents are in order**) together with the payment of the relevant fees (see the table below which has been reproduced from the Third Schedule Part A Items 4, 5 & 8) :-

- 1) Form F (<https://ippeh.gov.my/WP2016/forms/>)
- 2) Form D (for Registered Member) and Form D1 (for Probationary)
- 3) CPD certificate (for Registered Member **ONLY**)
- 4) Bankruptcy Status Declaration
