## NOTIFICATION ON THE INTERVIEW FOR THE TEST OF PROFESSIONAL COMPETENCE (TPC) FOR PROBATIONARY VALUERS AND PROBATIONARY ESTATE AGENTS

Dear Sir/Madam,

Kindly be informed that all Test of Professional Competence (TPC) Interviews for Probationary Valuers and Probationary Estate Agents respectively, shall resume to be conducted, via online, at a designated venue of the respective state in which the TPC Candidate / Examinee resides in.

In view of the abovementioned, all TPC Candidates / Examinees are to meet the following mandatory requirements before being qualified to attend to the TPC Interview:

1. The TPC Candidate / Examinee must have completed in being administered with the Covid-19 vaccination. Completed vaccinations according to the National Security Council is defined as:-
  - a) those who have passed fourteen (14) days from the day they have received their second dose for vaccines requiring two shots (Pfizer, AstraZeneca and Sinovac); or
  - b) those who have passed twenty-eight (28) days for vaccines requiring only one shot (Johnson & Johnson and CanSino).
2. Every TPC Candidate / Examinee must undergo a PCR test (at any medical facility which is authorised to conduct the said test) three (3) days prior to his / her scheduled interview takes place. The result(s) of the said test must be disclosed to the Board before the day of the interview and all expenses of taking the said PCR test is to be borne by the TPC Candidate / Examinee.
3. Should the result(s) of the said test be positive of being infected with Covid-19, the TPC Interview that was being scheduled for the TPC Candidate / Examinee shall be postponed to a later date.
