- a) those who have passed fourteen (14) days from the day they have received their second dose for vaccines requiring two shots (Pfizer, AstraZeneca and Sinovac); or
- b) those who have passed twenty-eight (28) days for vaccines requiring only one shot (Johnson & Johnson and CanSino).
- c) It is compulsory for all Property Managers to bring their own self-test kit (Covid 19) which you will need to do the test during the registration before entering to the Hall.
- d) Should the result(s) of the said test be positive of being infected with Covid-19, the Registered Property Manager will not be allowed to attend the Induction Course with immediate effect.
- e) The Property Manager must adhere to all the Standard Operating Procedures (SOPs) and Guidelines as promulgated by Majlis Keselamatan Negara (MKN) at all times.
