**To : REGISTERED ESTATE AGENTS (REA), REAL ESTATE NEGOTIATORS (REN) AND FIRMS**

Kindly take note of the followings:

1. New REN who obtained their REN Tags between 1<sup>st</sup> October 2023 until 31<sup>st</sup> December 2023 will have their REN Tags valid until 31<sup>st</sup> December 2024. Existing RENs who re-sits for NCC and have their REN tags reactivated between 1<sup>st</sup> October 2023 until 31<sup>st</sup> December 2023 will have a tag validity until end of 2023 only.
2. All REA are to ensure that their RENs shall renew their REN Tags on an annual basis, which expires on the 31<sup>st</sup> December of each year. To REN whose REN Tag was valid until the end of the year 2023, all REA are to ensure that all of their REN(s) to attend to the CDP courses **(as provided by the approved professional associations)** in order to renew their REN Tags for the year 2024. CDP courses for this renewal shall commence until **31<sup>st</sup> DECEMBER 2023 only.**
3. All expired REN Tags are to be returned to the Board.
4. All REA are to ensure that REN employed by them have registered their REN in the Board's BIS System with full name as per the NRIC. REN can include nick/short names on their business cards based on other names they have registered with the Board only.

5. Please be informed that the REN Renewal for the year 2024 will commence from 1<sup>st</sup> December 2023 until 31<sup>st</sup> March 2024. All REA are requested to submit their negotiator's CDP certificates via the Board's BIS System for the renewal application for year 2024. RENs are required to return their 2023 Ren Tags in order to collect Ren tag for 2024.
  
6. Please take note that failure to renew your license for 2024, shall constitute your license to be deactivated from the Board. For further inquiries and/or to ensure a smooth arrangement, all Firms/ REA are advised to contact the Board and/or to arrange for collection by setting an appointment with the person in charge from the REN Department.
